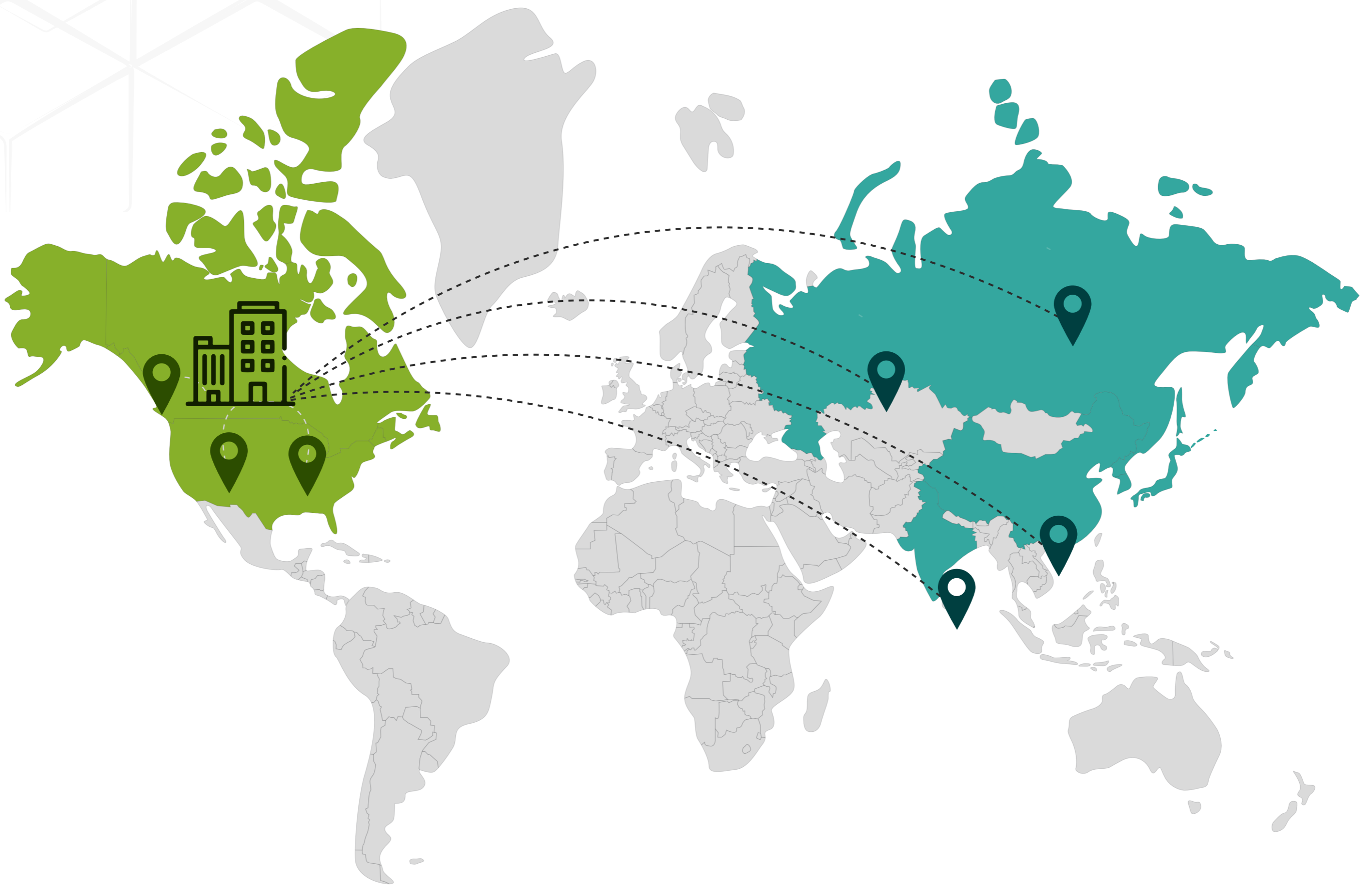


Difference Between Nearshore Vs Offshore Outsourcing
